

## **WUNA Monthly Meeting April 5 , 2012.**

The meeting was held at the Trinity Presbyterian Church.

### **I. Call to Order, Roll Call and Welcome**

President Gans called the meeting to order at 6:35 p.m.

### **II. Approval of Meeting Minutes (3/1/2012 & 3/13/2012) and Treasurer's Report (April 5, 2012):**

- a) Niethammer moved, seconded by Ervin to approve the minutes of 3/1/2012 with addition of Robert Pitts to attendance list. Motion passed by all attending with Gans, Mayers and Williams abstaining.
- b) Patterson moved, seconded by Ervin to approve the minutes of 3/12/2012 with clarification of Niethammer motion under item II "Overlay Petition Fund" to read as follows: "... spend remaining funds as needed to achieve the signature level goal." Motion passed by all attending with Gans, Mayers and Williams abstaining.
- c) Treasurer's report presented by Morse. Balance due on signs paid to vendor. City still to bill for installation. Report does not reflect Street Fair Beer Booth income from FAMA. Williams moved, seconded by Pitts Labate to approve. Motion passed by all attending with Gans, and Mayers abstaining.

## **VII. Street Fair Update**

Gans reported for Thomas, noting his great work in organizing beer booth. Thanks to neighbors who helped out. WUNA had the third highest beer sales during fair (over \$19,000 in gross sales). \$1,839.75 in tips collected for the Community Food Bank.

## **VIII. Mission gardens Plaque**

The plaque has not been printed. Sensibar moved, seconded by Mayers, to dedicate tree Brian McCarthy and have reflected on plaque. Motion unanimously supported.

## **IX. Board Discussions**

Mayers noted that there is a Downtown Neighborhood and Residents Council that is part of the Downtown Tucson Partnership and meets the first Monday of the month in the Parkwise conference room upon which WUNA has seat that he has filled. A new representative is being sought. Ervin expressed interest. Mayers to stay on until another candidate commits.

Morris presented the new neighborhood signs. They will be installed along the perimeter of the neighborhood. There are 24 extra. Final cost for installation still to come from Tucson Department of Transportation (Jesse Soto).

TKE ad KA requests for support were discussed by board. Sensibar moved, seconded by Patterson, not to support fraternities in the neighborhood and, should they move into neighborhood without support, consider requests after fraternities have been in their buildings for a year. Motion passed by all attending with Gans, and Mayers abstaining.

Mazaco sent e-mail requesting for two WUNA officers to meet regarding the one block taken out of the UOD. Gans and Morris expressed interest, Mayers will to be an alternate. Meetings considered for late afternoon on April 11 & 18 or 13 & 20. Gans to send notice to Board when meetings are set.

Referendum status discussed by board. Legal challenge update provided. Hearing scheduled for Friday April 6 at 2 pm.
